MESSAGE TO READERS

It is a pleasure to welcome readers to the *Drake Journal of Agricultural Law* and this inaugural issue in particular. This new journal will offer students, scholars, practicing lawyers, and those active in the formulation of agricultural law and policy a forum for the analysis and discussion of issues of agricultural law and other issues arising in the agricultural sector that imply or suggest legal solution. As such, the *Journal* reflects our commitment at Drake to the study of Agricultural Law as a distinct field of law of huge significance to the United States and even the world, and it also reflects the Law School's disposition for practical outreach to people affected by law, to members of the Bar, and to decision-makers in every arena.

Professor Neil Harl, in his introduction, refers to agricultural law as a "relatively young field," which did not secure "undeniable visibility in the pantheon of disciplines" until 1980 with the formation of the American Agricultural Law Association. Certainly there would have been many who would have agreed with Professor Neil D. Hamilton when he wrote, "One aspect of agricultural law that makes it conceptually difficult to perceive the area as a separate field of study is the number and variety of legal subjects that are involved in agricultural matters." The field is indeed broad. It possesses both public and private spheres, which are distinct yet constantly interacting. It ranges from contract and commercial law, to environmental and property law, to tax and antitrust. It is at once local, regional, national, and international. Yet there is a unifying focus that not only merits but demands recognition as a distinct field and makes highly appropriate the launching of a professional and scholarly journal devoted to its study and evolution. Professor Harl expresses it well when he suggests "that the basic polestar [of the *Drake Journal of Agricultural Law*] be pursuit of ideas with the capacity to improve the condition of the human family everywhere."

Thanks are due to many in making this new journal possible. I particularly want to compliment Editor-in-Chief Mark Reisinger, Chief Executive Editor Aaron Oliver, and other members of the Journal's Editorial Board, along with Brad Mason, L'95, and Matt Benda, L'96, who have shown great initiative, ability, and perseverance in developing the concept of this new journal, securing student support and participation, and launching the Journal in impressive fashion. Ronja Butler, L'95, as President of the Student Bar Association, facilitated discussions leading to development of the Journal; and members of the Editorial Board of the Drake Law Review have graciously and effectively provided assistance and
